

## THE HARRY CROSSLEY POSTDOCTORAL RESEARCH FELLOWSHIPS 2016 Submission date: 18 March 2016

The Faculty of Health Sciences invites applications for Harry Crossley Postdoctoral Research Fellowships to support talented young health sciences researchers who completed their PhD within the last 5 years.

The following conditions apply:

- Applicants must be under 40 years of age
- Applicants may not have held any prior professional or academic positions
- Applicants must have submitted their PhD thesis by the application deadline.
- Applicants should not be registered for study towards any degree at the time of assuming the fellowship.
- Applications must be supported by a suitable research host in the Faculty of Health Sciences.
- The fellowship is compliant with the rules and policies of the South African Revenue Service (SARS) and is therefore exempt from tax.
- Preference will be given to clinical and translation research.
- The Fellowship may not be held concurrently with full-time employment, or with any formal fellowship from UCT or national funding bodies such as the NRF and the MRC. Contingent on availability of funds, fellowships may be topped up using departmental awards.
- Fellowships must be taken up in the second half of 2016.
- Fellows will be required to enter into a Memorandum of Agreement with the University of Cape Town, and a Memorandum of Understanding with their research host.
- Fellows will be required to comply with the University of Cape Town's approved policies, procedures and practices for the postdoctoral sector.

There are no fringe benefits. The successful candidate is responsible for his or her own medical aid and insurance arrangements.

Value: R200, 000 per award. The fellowship is tenable for one year.

## Undertaking

Recipients will be expected to:

- Acknowledge the Harry Crossley Foundation in any publications emanating from the fellowships.
- Complete a 2-page report on research activities and achievements enabled by the Harry Crossley Fellowship.

## Application

Applications must be completed on the attached form and submitted electronically to: research.health@uct.ac.za by midnight on **18 March 2016**.

A review committee comprising members of the Faculty of Health Sciences and the Harry Crossley Foundation will select successful applications.
