We invite applications for consultant **isiXhosa-speaking Transcribers** for a research study investigating motivations and obstacles to HIV prevention methods (with a focus on Pre-exposure Prophylaxis PrEP), with the goal of informing effective HIV prevention communications and delivery strategies.

Consultants will transcribe interviews about men and women's lives, aspirations, knowledge and attitudes towards HIV prevention and the ways they conceive of sexual and social risks relating to HIV. Potential contributions to other studies may be available as well. Transcription can be conducted on a part-time or full-time basis. Consultants will be expected to provide their own computers and can transcribe from home during the hours that suit them.

#### **Requirements:**

- Tertiary qualification
- Prior transcription experience is essential
- GCP (Good Clinical Practice) certification
- Previous work experience in HIV, sexual health, or with adolescents will be advantageous
- Fluency in English and Xhosa
- Computer literacy (Ms Word)
- Excellent verbal and written communication skills
- Demonstrated ability to work independently
- Ability to maintain a high level of confidentiality at all times
- Excellent planning and organising skills
- Attention to detail
- Work standards

#### Responsibilities

- Translate and transcribe Power Study interviews verbatim, using the prescribed format (into English)
- Respond to data queries related to transcripts
- Check the quality of other transcriber's work, if requested
- Attend project training as required
- Participate in in-person and skype team meetings
- Ensure non-biased, consistent, complete and accurate data collection
- Ensure that good clinical practice guidelines are followed and confidentiality with regards to study materials is protected at all times
- Ensure that qualitative standard operating procedures are followed at all times, with exceptions or deviations noted on the appropriate deviation form
