The nurse's role in partnering with mothers/carers to give oral medication to their hospitalised child

Background


- Adverse drug events and potential adverse drug events represent a considerable hazard for the paediatric inpatient population¹.
- Children are often reluctant to receive medication from nurses and eventually medication is given by the parents².
- Current practice in many wards is for nurses to hand over medication to mothers to give to their children, but this is an 'informal' practice and lacks evidence-based guidelines³.


Purpose

- Develop a contextualised and adapted evidence-based guideline to enable nurses to partner with mothers/carers, for the mother/carer to safely give oral medication to their hospitalised child under the supervision of a competent nurse.
- Good medicines management is essential for high standards of clinical care.
