This report is a record of the 212 electronic articles in South African media that contain the string of letters 'actuar', for the period of 1 April to 30 June 2021. 123 of these articles appear in media sources that do not receive very high circulation (e.g., local newspapers, blogs and special interest web pages). These articles are only discussed in the very last section of this report.




Figure 1: Breakdown of 89 widely circulated articles in different news media sources
