Overview

This report is a record of the 299 electronic articles in South African media that contain the string of letters 'actuar', for the period of 1 January to 31 March 2020. 209 of these articles appear in media sources that do not receive very high circulation (e.g. local newspapers, blogs and special interest web pages). These articles are only discussed in the very last section of this report.


7. A breakdown of the articles by actuarial practice area
