## ASSA Media Report

# 1 July 2021 until 30 September 2021

## <u>Overview</u>

This report is a record of the 253 electronic articles in South African media that contain the string of letters 'actuar', for the period of 1 July to 30 September 2021. Please contact Pieter du Toit (<u>pddutoit@gmail.com</u>) or Billy Enderstein (<u>billy.enderstein@gmail.com</u>) to get access to the full database of articles.

115 of these articles appear in media sources that do not receive very high circulation (e.g. local newspapers, blogs and special interest web pages). These articles are only discussed in the very last section of this report.

The intended audience of the report includes members and employees of the Actuarial Society of South Africa and participants of Mind Matters.

## 1.1. Covid-19 updates and the impact of alcohol bans during the pandemic

- Discovery Health actuary Emile Stipp, was mentioned in nine articles, mainly discussing a calculated estimate of up to four out of five South Africans who have contracted Covid-19. Read more in one of these articles below: Deaths data shows 80% of South Africans may have had Covid
- Although SA removed off UK's red list in October, two articles in the third quarter included Emile Stipp, amongst others, discussing research that points to why a review is necessary.
   <u>With Beta variant gone, SA continues to fight to get country off UK red list</u> <u>Scientists slam UK decision to keep SA on red list</u>

 A further nine articles highlighted a South African Medical Journal (SAMJ) study with Professor Tom Moultrie as the lead author.

 The study also "caution that complete restrictions are not a viable long-term solution to averting unnatural deaths."

The alcohol industry responded with critique for the study: <u>Alcohol industry hits back at</u> <u>study backing booze bans</u>.


## 7. A breakdown of the articles by actuarial practice area
