Overview

This report is a record of the 189 electronic articles in South African media that contain the string of letters 'actuar', for the period of 1 October to 31 December 2021. 88 of these articles appear in media sources that do not receive very high circulation (e.g. local newspapers, blogs and special interest web pages). These articles are only discussed in the very last section of this report.




Figure 1: Breakdown of 101 widely circulated articles in different news media sources
